Operational Reporting Versus Analytical Reporting

One of the great strengths of MultiValue systems is the efficient representation of transactions; we can express complex business logic succinctly in very few files. In the right hands, our rich, expressive query environment exposes these files, extracting the detail and summary transaction information we need to run our business. But. what if we want simpler access to operational data and quick export to spreadsheets or trending and drilldown analysis to improve our business? In this article, we will look at the complementary nature of operational reporting and analytical reporting and the strengths and weaknesses of their respective applications and third party tools.

Operational Reporting

Also called Enterprise Reporting or Transactional Reporting, these are typical "canned" reports or the ad hoc queries that a MultiValue expert can pull up so adeptly in one or two commands that it seems like black magic to the uninitiated. We've all had conversations like these:

"I need a list of last month's late orders!"

"Do you want that sorted by branch number?"

"Sure — you read my mind!"

"I need a list of all customers who ordered last month!"

"Do you want contact info with those addresses?"

> "Contact info too you deserve a raise!"

Unfortunately, sometimes requests are not possible because we don't have a MultiValue expert at hand — or the information we need to run the business is not captured directly by our applications, in the form we need. Resourceful workers will gather data manually and capture it with pen or spreadsheet — anything to get their job done — unfortunately this is a time-consuming and costly approach. We get effective operational reporting only when requirements align closely with application files because the extraction process is quite limited.

The actual reporting process consists of scanning a set of records and presenting elements on a screen or page in human readable form. This approach dates back to an era when resources were very constrained. We assemble and sort a set of candidate record keys; then, in one pass, read and format or summarize each record on screen or to a spool file. This minimizes system requirements because we only hold one source record (and any running totals and page layout information) in memory during the output phase.

In spite of the single-pass mechanics, the LIST and SORT verbs, combined with the information stored in dictionaries and a variety of display options, provide an enormously flexible method of defining reports. With enough experience, it is possible to create impressive output using built-in command-line reporting. In the eighties, I attended a seminar where an elaborate LIST statement was actually used to cut automatically numbered payroll checks. Unfortunately, this is still state-of-theart for native MultiValue report output, and molding that output to fit the online world or populate a spreadsheet is not easy.

Ignoring output issues, a perfect report will still be out of date soon after we run it because of the nature of reports - they capture a snapshot of transaction data. Less obvious are changes to the requirements that drove the canned report in the first place. Solving these problems can turn into a real management issue. How do you rerun a report to capture the most recent data? Where is the report stored? What do we call it? We can certainly create Paragraphs or PROCs, but how are they stored, accessed, organized or maintained, and by whom? We can overwrite queries or forward queries to unauthorized parties or five different people can run the same query simultaneously — bringing our operational system to its knees.

Maintenance of queries is not the only management headache. The query language complexity and complexity of the underlying file layout also increase load on the IT department. Training end users to use select lists effectively and understand the query syntax takes time and there are few resources for this type of training. Even with report training, exposure to the application

dictionaries can often overwhelm the keenest end user. The net result: IT staff will be generating reports as long as they admit to knowledge of that black art, and they will always be behind the curve.

Guided Operational Reporting with Report Generators

One solution to simplifying complex tasks is a "wizard" approach breaking the reporting task down into smaller steps guided by a third party report generator. These have been around for a number of years and have recently embraced the familiar Web Training is interface. minimized because report generators hide much of the complexity of the underlying query language, and it is getting possible to create a report without direct knowledge of the underlying file structure. The earliest report generators checked query language syntax and prevented the creation of invalid gueries. Today, report generators are also aware of file layouts

and can help create queries that are both efficient and more likely to create desired results. Additional features include user-friendly menus and a security layer that controls access to data as well as query maintenance functions, reducing load on IT.

Other Approaches to Operational Reporting

We can also use ODBC or XML to pull operational data out of the MultiValue environment in order to facilitate reporting. In the September/October 2002 International Spectrum Magazine, author Michael Ballard devotes

most of "MV ReportCard: Lessons Learned In MultiValue Reporting" to the overhead associated with ODBC, primarily to enable mainstream reporting tools like Crystal Reports to access MultiValue data. Michael does not paint a pretty picture. More recently, new middleware based on Microsoft's .NET technology has emerged as a possible reporting solution. The fact that .NET is based on XML solves some of the structural issues with ODBC. but it is an expensive proposition if your organization is not leveraging the .NET middleware for oper-

ware for operational use too. Another solution using XML to preserve the Multi-Value structure of the exported data is the new MITS Report product, described in the sidebar (see page 47).

Limitations of Operational Reports

Let's revisit those operational queries that we so easily dispatched earlier, but with an added wrinkle that will sound both annovingly

reasonable — and impossible with our "single-pass" query tools:

"I need a list of last month's late orders!"

"Do you want that sorted by branch number?"

"Sure — can you give me the percentage change from last month in order count and dollar volume too?"

"I need a list of all customers who ordered last month."

"Do you want contact info with those addresses?"

"No, but I only really need the top 10 customers last month."

These kinds of queries are typical of analytical reporting. They are essential in today's business climate as managers seek to identify under- and over-performing aspects of their operations to reduce costs and improve results. They also underline the two main limitations of traditional reporting against operational files — the restriction to sorting by value forced by the single-pass technology and the inability to compare multiple sets of data (Figure 1).

This progression from operational to analytical reporting mirrors the role of the report recipient. An operational report might supply a list of late orders to help operations improve their turnaround. Middle management might look to a tactical report identifying branches with above or below average turnaround trends to gain insight or focus attention, while upper management may look at enterprise-wide turnaround figures to see if they meet strategic targets. An exciting prospect for analytical reporting is the ability to supply these advanced tools to people in the field, allowing them to act as change agents pursuing goals instead of waiting for guidance.

If you are not providing this analytical capability through application pro-Continues on page 8

grams or online analytical processing (OLAP), resourceful managers are surely taking pencil or spreadsheet in hand to get the job done on their own. For a sole proprietorship that may be fine, but the astounding return on investment for OLAP tools means almost any size organization can benefit.

Since operational reports work on one pass through the data, we cannot easily use them to compare different sets of data, for example, comparing sales numbers from month to month or ranking by summarized totals. It is possible to accomplish this analysis through custom programming, and some vertical applications do this with complex multi-pass BASIC code; typically generating a summary history file with delimited keys of the form year*period*product-type*product. This programming approach can yield powerful results that would not otherwise be available, but there are a few drawbacks.

Generating management reporting with analytical capabilities using BASIC programs involves an intimate knowledge of the underlying application as well as detailed insight into the reporting requirements. The authors of the application software may have the former but lack detailed specifics of the latter. Putting the hooks into your application to extract transactional information and load it into a summary file adds complexity to your code base. If you bundle this with transaction processing, you slow operations down; otherwise, you create another process to schedule and administer.

Reporting from these summary files can be performed with command-line queries, report generators, or programmatically. If you use traditional reporting methods to access this data, you are subject to their presentation limitations and interactive analysis is not possible. It is possible to create links manually between queries in some modern report generators, emulating interactive analysis, but mainly you gain the ability to view results easily online or to export to a spreadsheet for further manipulation. If you use a BASIC program to access the data, you can tailor the reporting, at the expense of even more added complexity — but users may still press for spreadsheet integration.

Business Intelligence and Analytical Reporting

A more general approach is using third party business intelligence OLAP or ana-


lytical reporting tools. These copy the transaction data into a structure optimized for comparing and ex-ploring summary totals with linked and pre-aggregated sets of data to enable trend and drill-down analysis. This creates a view of a process that allows you to derive insight quickly to help you improve that process (Figures 2-4).

Although business intelligence (BI) draws information from the underlying operational data, it is actually modeling the business process, not just assembling statistics. Reporting directly from operational data files to operate a business from day to day does not constitute BI. Reporting with a goal to improve the process, to track trends, to identify under-performing categories and the underlying root causes are the hallmarks of BI.

Operational systems break down a business process into individual transactions that can be performed independently, reliably, and efficiently; BI systems look at the business process as a whole and involve trade-offs that would be impractical in transactional systems. To provide rapid on-line analytical processing, we pre-aggregate transactions in a structure optimized for efficient navigation. Since each transaction can affect hundreds of elements in this structure, it is impractical to update this structure during the actual transaction.

Most BI solutions involve batched extraction and summary of transactions into a hypercube structure. We can usually make these batches arbitrarily small to allow transactions to *Continues on page 47*



Understanding the Real

The Web is laden with flash, but the interaction itself is basically the mainframe-like data entry systems. Ajax techniques transition us into the world of GUI controls.

Sometimes I get things wrong and assume that people understand the benefits of certain technologies. Over ten years ago, I started writing and talking about the Web at Spectrum, and I might as well have been describing theories of interest rates, bond prices and arbitrage regulations. It took a few talks and articles to get folks to understand that there was a place for the technology at the MultiValue business table.

Likewise, in a previous issue, I gave some technical information regarding Ajax without really explaining to everyone the ramifications of the technology. I thought it best, therefore, to backtrack some and make sure we all understand what Ajax is all about.

After all, there's does seem to be hype about Ajax Web applications; you may be assuming that Ajax is some incredible new plug-in or programming language. I got an email that suggested that the reader was under the impression that Ajax was not possible because the browser wasn't able to download the Ajax plug-in.

So, as a reminder, you don't need to do anything particularly special. You can use Ajax right now. That is, I'm assuming you have a Web browser released in the past five years -Internet Explorer, Firefox, Safari, Netscape or Opera. If you've used Google Maps or GMail, then you've used Ajax applications.

These applications vastly improve the richness of Web applications. A wellwritten Ajax application changes in real-time; you won't be forced to wait for a page to reload any time you click on something. You can actually drag boxes around; the pages can refresh themselves with new data or images; pages can be re-formatted without redownloading. And again, there's no special browser or browser plug-in required. Ajax is merely a programming technique that milks all the features of today's browsers to generate something that feels less Webby and more Windowsy.

then add whatever information was needed. Were you on a shopping cart page but forgot to enter the area code in a phone number? You'll have to start all over again. It's an electronic version of lather, rinse, repeat.

I can't even imagine how many e-commerce sales have been lost because the shopper encountered one too many error messages and gave up.Ajax removes the wait; the page does not reload — the browser responds with its edit checks as you go about your business.

Pages Update in Real-time: Ajaxenabled pages update themselves in real-time. Many news pages, including Yahoo for example, redraw the entire page at certain time intervals, such as every 10 minutes. In contrast, a browser using Ajax techniques will poll the Web server every few seconds in the background, so it's able to update any and only information that needs changing. The rest of the page does not change, flicker or move.

Graphic Interactiveness: The Web is laden with flash, but the interaction itself is basically the mainframe-like data entry systems. Ajax techniques transition us into the world of GUI controls. You might see animations such as dissolving text that tell you something's being saved, you can drag items around the page, you can see static text become editable fields when you move your mouse over it.

What Ajax Isn't:

Plug-in: Ajax applications do not use special browser plug-ins or other types of additional software.

Browser-specific: Just use a browser from this millennium and your Ajax Web page should work.

Proprietary: "Ajax" might be a common name in the pantheon of house-hold marvels, but when it comes to the

Web, Ajax is not a company, a product, or even a mythological figure. It's not even the name of a standard or international Internet committee. It's a programming technique that blends the benefits of several technologies.

Why Does Ajax Seem So New?

The term Ajax was coined only last year. The approach has been there for a long time, but until it was given a NAME, it was tough to encourage the use of some nameless programming technique. Ajax is pretty much just geek lingo. It stands for Asynchronous JavaScript XMLHttpRequest (with blue dots of DHTML and DOM, I suppose). So, we're talking about stuff that's been around: Javascript and DHTML, to let applications respond to mouse clicks and other events; DOM, so that Web applications manipulate the graphics and display; and XMLHttpRequest, so that the browser and the Web server can communicate without having to refresh the page. multiple technologies such as Ajax. Coder beware!

What's Actually Happening:

Ajax processing seems more akin to traditional GUI programs than traditional Web pages. The JavaScript monitors events and manipulates objects when defined events occur. The manipulation may head back to the Web server and perhaps a database server. Interestingly, there the interaction is asynchronous, as the event-listening is handled separately from the event-processing.

Here's a typical Ajax Transaction Flow Within the Browser:

Page Hit: Page gets requested in a link or URL.

Initialization: The page loads. Objects are initialized and possible event loops are started.

Event Loop: An event occurs on the browser, such as a keypress or mouse movement.

• The event is sent to one of the browser's objects, that in turn sends a request to the Web server.

• Web Server processes the event (with a possible run to a database server).

• The Web Server replies to the calling object.

• The object takes the reply and updates variables and calls functions,

based on the initial request that was programmed.

So that's it. Ajax isn't something more than a combination of different tools with solid programming techniques. It's slick and clever, but more importantly it's vastly usable in many of our MultiValue forms. In future articles, I'll return to the technical aspects of Ajax and see how it can make your forms that much more user-friendly. <u>is</u>

Programming for Special in OpenInSight

Time.

There never seems to be enough of it. We hate to waste it. We usually wish we had more. As programmers, developers, and consultants, to get more time, we need some speed. How can we achieve this? And what do we mean by speed?

For the purposes of this article, let's define speed as the ability to get a required task done in the least amount of time. And the areas we want to address for this article are speed in developing, speed in running the applications we develop, and speed in supporting, enhancing, debugging and modifying.

In this article, we'll be discussing tips and techniques that make sense in any programming environment, and then focus specifically on commands and techniques in OpenInsight's Basic+ that provide the biggest bang for the buck, as far as speed, when running.

Just to clarify, this isn't "pie in the sky" or "Ivory Tower" advice. Even though

I'm president and CEO of Revelation Software, I still code nearly every day, and not just for OpenInsight. All of the developers here at Revelation Software also do work in the field as developers and consultants, so we have knowledge and experience with real world problems and needs. Now, on to the show.

Speed in Developing

Speed in developing is not a measure of how quickly one can type, or how many lines of code can be written in a day, although being a fast typist is an advantage. The average person typing makes an incorrect keystroke 3% of the time; some studies indicate that the error rate for programmers is nearly 20%. The following tips work for all flavors of MultiValue Basic, and even most other languages.

• **Create Reusable Routines** If you've done a lot of coding, you've doubtless encountered those occurrences where you find yourself writing a chunk of code, and it seems eerily similar to a chunk of code you've written before. The next time that happens, stop a moment. It's usually worth your while to create a centralized, parameterized routine that's generic. A generic routine like this can be used over and over again, and used safely because it's been run so many times that it's thoroughly debugged. I would warn against going off the deep end and making routines that are so generic that they become useless — just use some common sense.

 Remember Where Things Are, or Have a Good Search Tool. If you've been programming for a number of years, you may be familiar with the saying "If you haven't looked at your code in six months or more, it may as well have been written by someone else." I don't think that's necessarily the case, but sometimes you do forget what you've written before. If possible, keep a catalog, in your software, about some of the routines you've written, or, if all else fails, find or write a good search tool. We have one that we use written by a MultiValue developer named David Sigafoos. His tool is called FindInFiles; and I highly recommend it. Other Multi-Value flavors certainly have similar tools; otherwise there is a niche market there to be exploited!

• **Be Consistent** Sounds easy, but many do not do it in practice. Name your variables the same from program to program when appropriate; it makes reading them easier, and lends itself more to cutting and pasting from one program to another. • Anticipate Change When you're writing your code, know that it will be changed, either by you or another developer. Write your programs in such a way that you can modify them without having to tear them apart.

• **Tend to the Little Things** These are the little things that when used in a consistent manner and added to your own personal style, will make your programming life easier over time.

Some Little Things to Attend To

The devil is in the details, or so I've heard. Here are some tips specific to developing in OpenInsight that will make your development go faster.

• Use standards! Some shops require that a file be opened to a variable named f_filename; i.e. open BOOKS to F_BOOKS.This way you'll always know the file you're reading from or writing to. Another suggestion is to make your common variables end with an @ sign, so they can be differentiated at sight within a program. If you or your shop has standards, maybe you should review or enhance them. If you don't have any formal programming standards, it might be a good idea to write and use them now. Nothing fancy or complicated, just a set of rules and standards to follow.

• Put spaces between the parameters of called subroutines or functions. For example, this statement: X = XLATE('BOOKS',@ID,12,'X') works fine, and so does this one: X = XLATE('BOOKS', @ID, 12, 'X'). That's because most editors jump to the next blank space when the key combination of control-left arrow or control right-arrow are pressed. This is much quicker than arrowing or backspacing and typing it in again.

• Don't embed functions within function calls. Although it works, it can be a real bear to debug. Make the program two lines longer, and use the result from the first function call as a parameter in the second function call. When debugging it's much easier to see the values as they are passed.

• **Debugging** - **real and conditional.** Basic+ supports calling the debugger through the use of a DEBUG statement. But you don't always want to drop to the debugger every time as you are running through a program. In those cases, you can do a conditional debug — if condition, then debug.

• Use Equates. In OpenInsight, programmers can use an equate statement to have variables take on more meaningful names. For example, in the Basic+ function MSG, the parameter for the caption (title) to be displayed is the 12th parameter. In case I'm not sure of the number, or don't want to look it up, I'll just \$Insert MSG_EQUATES into my program, and then I can just refer to the parameter with the name mCaption\$, e.g. param<mCaption\$> = "This is the title". Equates also make programs easier to read and faster to debug.

Speed in Running

While the tips for developing can make you a more efficient developer, programs are written and modified a few dozen times, but they are run hundreds or thousands of times. The following section will give specific items within OpenInsight that will show a developer where they can save enormous amounts of time. It's not that the alternatives are bad programming, but like any system, when you know some of the secrets, you can really get some great speed gains.

Fastest Ways for String Handling and Extraction in OpenInsight

OpenInsight, like all flavors of Multi-Value, is just a large string handling database. All of our data is strings; we just extract and parse it out by characters that mean something special to our databases: ASCII 255, 254, 253, etc. And it's important to remember that because working with strings as strings is almost always faster than treating them as dynamic arrays.

As a note, the tests and speeds here were recorded on a copy of OpenInsight 7.2, running on a standalone Toshiba 6100 Satellite Pro, 2.0 gigahertz, with 1 gigabyte of RAM, running Windows XP. This is a fairly common laptop today. When working with a file I'm using a file named DEMO_CUST with 100,000 records.

For example, suppose you have a program that is building an array of 25,000 elements. Given that, we'll use a For-Next loop to build it, there are basically two ways to make it — as a string or a dynamic array. The first example uses dynamic ontinued from page 17 🛛

arrays to add elements to the array. The second example uses string handling.

Example 1

for i = 1 To 25000 array = i Next i

Example 2

for i = 1 To 25000

If Len(array) Then array:=@fm:i Else array = i Next i

Which is faster? Number two. Example one takes 13.81 seconds on the test platform. Example two takes .05 seconds, so it's about 280 times faster. Wow!

Extracting data from strings is similarly disparate. For example, suppose we have an array with 20,000 elements. To loop through the array and examine every element, we have again two basic ways of doing it. The first, as seen in example 3, uses a For-Next loop and dynamic array operations to extract the elements, and example 4 uses a Loop-Remove string extraction process.

Example 3

Example 4

num_items = Count(array, @fm) + (array # '')
For i = 1 To num_items
 item = array<i>Next i

So, which is faster? Example 4. Example 3 takes an average of 8.5 seconds, while Example 4 takes .015 seconds. Again, the string processing is tremendously faster, about 500 times faster.

In cases where the arrays you are working with are only a few hundred or low thousands of elements, it's probably not worth the extra typing to use the string extraction syntax, and just stick with the dynamic array.

Cunning Use of Xlates

In Revelation, both our DOS products and OpenInsight, we have a command called XLATE. Xlate is a function that

will go and pull data from a field or fields in a record in a file. It can either bring

back the data from a single field, or from a whole record. It can be used like a READ, READO, or READV. Xlates are often used in our calculated columns to display information from another file when the key to that data is stored in the current file.


Xlates can be used to bring back either an entire record, or just the contents of a single field. Sometimes programmers will use an Xlate to get a field that is performing an Xlate itself. It is always faster to duplicate the functionality of the two Xlates in your program. It is also faster to Xlate an entire record rather than do multiple Xlates to

> the same record, although the difference is not that great; Xlate caches the record it has just read in case another Xlate call is made to it.

Programming for Social in OpenInSight

Selects, Indexes, and Btree.Extract

Nearly every reporting or processing program in a MultiValue system uses data files. Most of these programs do not deal with the entire file, rather just a subset of the data. These subsets are created using some variant of the basic SELECT command. OpenInsight's version of the SELECT command is called using the RLIST subroutine; it is effectively the same as an EXECUTE or PERFORM.

In OpenInsight, when you select on a field to have a value, you'll use a WITH or BY clause. A good rule of thumb in the Revelation world is that when you do a lot of reporting or selecting on a field, you put an index on that field, and in most cases you put a Btree index on it.

OpenInsight supports three types of indexing: Btree, Cross Reference, and Relational. Btree indexes, when they are built, build a unique list of the contents of the field that is being indexed, and builds a corresponding list of keys that are associated with those values.A Cross Reference is similar, except that it is used on strings, and there is a series of characters used as delimiters to parse the strings into component pieces. These component pieces are then indexed with a Btree. There is also an associated 'Stop List' which is a list of words that shouldn't be indexed, such as 'A', 'The', 'Inc', and so on.

A relational index keeps the keys from a secondary file stored in a multivalue field in another table, with the relationship back to the primary table being based upon the contents of a field in the secondary table. For example, suppose you had a file of classes and a file of students, and the class file had an ID, time, location, and a MV list

of students, and the student file had an ID, name, address, email, and so on. If you wanted to see what classes a student was attending, you might have to run a select statement along the lines of SELECT CLASSES WITH STUDENTS CONTAINING "XXX". This will take more and more time every time an inquiry is made. However, if you added a new MV field in the Student file named CLASSES, and set up a relational index between the two tables, the new CLASSES field would contain the IDs of all classes that the student was in. From that point forward the CLASS-ES field would always be up to date, and could be listed as needed.

A good point to remember about OpenInsight's indexing is that once it is set up initially, the indexes maintain themselves automatically. When a write is made to a file, the changes to the indexed fields are tracked and put into a pending indexing file, and the pending changes are handled either by systems on the network with idle cycles, or updated just before a select statement.

Given that the indexes in OpenInsight make searches and selects faster from TCL or in reporting, how can they be utilized from a program? There are a number of index specific commands in Basic+, but the most frequently used is a routine named Btree.Extract, and it is almost always faster than doing a select statement. Looking at examples 5 and 6, both select all records from the DEMO_CUST file. Using the two examples above, the SELECT takes about .01 seconds to run, while the BTREE.EXTRACT goes so quickly that the time is always measured as 0. If you multiply that by the number of times a particular process is run, the time savings is tremendous. So, Btree.Extract is definitely fast, and should be used whenever you need to get records using indexed fields.

A good point to remember about OpenInsight's indexing is that once it is set up initially, the indexes maintain themselves automatically.

Sorting Arrays - V119

Whenever you have a dynamic array that you want to sort, there are a couple of ways to do it: either looping and sorting yourself, or using V119, OpenInsight's sorting algorithm. (An aside — we really should change the name of this routine; I mean, V119 is just so intuitive that it's a sort routine.) Although there are many and various sorts that can be written using Basic+, V119 will always come out on top.

In the following examples, there is a variable named STRING which is an @FM delimited list of 250 items in random order. Example 7 sorts the list using a very efficient Loop-Remove-Locate algorithm, and gives us a sorted result. Example 8 does the same, but uses V119.



As you've probably guessed by now, example 8 is the faster of the two, but how much faster? Again, difficult to tell, but the LOCATE takes about .02 seconds per test, and the V119 keeps registering 0. Recommendation: use V119 wherever possible.



the command in a program and pressing the F1 key will bring up our context-sensitive help, as seen in figure 1.

Speed in Debugging

If you follow the tips and techniques above, enhancing and supporting your code should become easier. But debugging? How does OpenInsight make that easier? The answer is our debugger. The OpenInsight debugger can be called from a program, it can be hidden from the users, or it can be replaced with your own program. For the purposes of this article we'll limit the scope to calling the debugger from Basic+.

Calling the debugger from Basic+ is as simple as putting the DEBUG command in a program. It can either be called conditionally, or explicitly as seen in Example 9.

Example 9

As can be seen, there are four windows in the debugger allowing viewing of source code, the call stack, global variables, and local variables. Clicking on any of the windows will provide a more detailed view of its contents. Figure 3 is a view of the local variables.



Once the debugger call has been compiled into a program, when that line is executed during runtime, the debugger appears, as seen in Figure 2.



Looking at the local variables we can see that many have not yet been assigned at this point in the program, but the variable STRING contains an @FM delimited string. Double-clicking on this variable will cause it to launch into a new window, with each field on its own line, as seen in Figure 4.

If a variable were to contain values or subvalues, they in turn could be expanded as well. As you can see, it is much easier to look at programs and variables this way than with many existing MultiValue debuggers. Also,

So, as can be seen in the examples above, there are good ways of doing things from a speed perspective, and there are better ways. The examples that have been provided are given in that they offer some of the biggest bang for the buck from within OpenInsight programs themselves. There are others, but lack of space doesn't permit us to expand on them.

Where Are We and Where Are We Going?

The OpenQM project was launched a little over a year ago, bringing the already established QM MultiValue database into the spotlight by making the source code available under the terms of the General Public License (GPL). In this article, we will look at how this increased exposure has affected the product development and how we see the future.

The OpenQM project evolved out of an inhouse tool that began its life back in 1992. This was taken forward for use as an embedded database in application software produced by Ladybridge Systems and was subsequently launched as a product in its own right in mid-2001, quickly attracting users around the world because of its low price and the ease of migration from Information-style environments.


The open source release in September 2004 was linked to announcements at both the London and U.S. International Spectrum conferences and was greeted with great interest by potential users and by some of the established vendors in the MultiValue market. Here was something that could revitalize the MultiValue database world, potentially reversing the trend where experienced users were leaving the industry while new entrants tended to be more familiar with fully normalized products such as MySQL or Oracle.

Within a matter of days of the GPL release, over 100 developers had signed up to work with the open source version. Some of these, as one might expect, were simply interested in seeing what they could get for free but others saw this as an opportunity to take MultiValue databases into places where they had not been before. At the same time, the launch of a free license for genuine commercial application developers resulted in a large number of applications and development tools being migrated to OpenQM from other platforms.

There has been some confusion amongst users about the relationship between the commercial and open source versions of the product. The name OpenQM is used to reference the whole project, both commercial and open source. This provides a coherent naming across all documentation, Web sites, product components, etc., and reinforces the availability of an open source version. The commercial product contains the most current certified product components. Any user with a "mission critical" system should use this as it is fully supported across Windows, Linux and FreeBSD by Ladybridge Systems and our dealers and distributors. The commercial product also includes other bundled components and the availability of additional services for its users.

The open source is a derivative of the commercial product, released in Linux form only, though users are free to migrate it to other platforms. The open source is not updated at every commercial release and hence tends to lag behind. Because we have no control over what the user does to this source, support services are limited and only available on a chargeable basis. The attraction of the open source is that it allows developers to add new features that require modification of existing components. They then have the option of offering those developments back to Ladybridge Systems for incorporation into the mainstream product.

The rules governing what can be done using the open source are set out in the General Public License. In simple terms, a user is free to use this source for their own purposes, but distribution is only allowed if

the modifications are also released under the terms of the GPL.

So, who uses OpenQM? At the time of writing, licenses for the commercial version of the OpenQM database have been issued to users in 43 countries around the world. These users span industries as diverse as local government, education, law enforcement, medical systems, builders' supplies, retail sales, car dealerships, insurance, emergency service control rooms and, of course, software development.

The last year has seen OpenQM develop rapidly to meet the needs of new users. Many of these have come from Pick-style environments, so much work has been done to ease migration by adding features not previously in OpenQM such as A/S-type dictionary items, correlatives and Procs. Other developments have introduced new functionality that we believe to be unique to OpenQM such as dictionary link records, process dump files, cumulative fields in queries and a number of new QMBasic functions. Although most of this work has been done in-house, there have been some useful contributions from the open source community and there are some exciting projects in the pipeline.

We have chosen AccuTerm as our preferred terminal emulator as this combines a highquality character mode interface with advanced graphical features to put new life into legacy applications. All commercial OpenQM licenses now include free activation of the AccuTerm terminal emulator, further driving down the cost of ownership of a complete MultiValue environment.

What does the future hold for OpenQM? As users migrate from other MultiValue environments, the product will continue to develop, adding new features to make the transition easier. OpenQM is not a clone of any other MultiValue environment and will never provide total compatibility, but the majority of the more important issues that arise in migration have been addressed. Moving to OpenQM will always require some work, but users who have already taken this step report that the benefits are well worth the effort.

The majority of OpenQM users are taking forward legacy applications. Often these come from "green screen" origins and the move to OpenQM is an opportunity to revitalize the application by adding a GUI front-end using the QMClient API. This was originally written for use with Visual Basic but was quickly extended into a library for use in C programs. More recently, at the request of a developer in France, support has been added for Fantaisie Software's PureBasic to enable development of GUI applications for Linux users.

With the growing use of Web-based applications, OpenQM can be used with Webbased tools such as Coyote and Freedombase. Alternatively, effective Web applications can be built in OpenQM with no external packages by use of a simple CGI or PHP front end. The dealers area of our Web site uses this latter approach to support the license generation screens. More advanced Web interfaces are under development.

Current versions of the commercial product run only on Intel platforms using Windows or Linux. A Mac version is running on a development system and other platforms are expected to follow in response to user demands as these arise.

Contrary to the strategies of most software suppliers, it is the policy of Ladybridge Systems to issue new releases of the commercial product very frequently, typically about every two weeks, leaving users to review the list of new features and decide if a release is of interest. This release strategy combined with what we believe to be unrivalled responsiveness in handling user enhancement requests results in a very rapidly developing product.

The low cost of OpenQM combined with the maintenance-free file system makes it ideal for "shrink wrapped" applications and, with even lower costs for high-volume single user licenses, this is likely to be an important market in the future. At the other extreme, OpenQM has been successfully tested with 1,000 simultaneous users on a Linux system and should be able to support larger user populations. <u>is</u>

The professional's starting point for SSRS is the Report Designer, a complete IDE utilizing the functionality provided by Visual Studio. In fact, all of its functionality is supplied in VS 2005 Professional and above, so for those not inclined to purchase Visual Studio, a Reporting Services "only" version of Visual Studio is bundled with SQL Server 2005 for Report Designer. For the professional, therefore, reports can be developed and deployed and the BlueFinity RSDC employed to access all the major MultiValue databases. RSDC provides a simple-to-use wizard interface for the specification of the database connection, query and selection commands.

The Report Designer can be used to define a report layout, preview a report, and publish a report to a test or production server. 

.NET and the MultiValue Developer

As an IT professional charged with maintaining and extending the functionality of a MultiValue system, you are probably wondering what impact, if any, the latest release of .NET will have on the work that you do and the decisions that you make.

As you read different articles about .NET, you probably encounter a lot of terminology, some of which may seem strangely familiar to you. The reason for this is that some of what .NET brings to Windows development are features that, as a MultiValue developer, you will have taken for granted. On the other hand, there is a lot in .NET that is both new and different from what you are familiar with.

I will try to demystify some of the new features, so that you know which ones you should be familiar with and which will be truly new to you. I will also explain why some of these features are important to you and why you should be moving toward adoption of them.

What Is .NET?

.NET actually consists of two components. There is the .NET framework, which is really a run-time environment for executing applications written using Visual Studio .NET, and there is Visual Studio .NET. Visual Studio .NET is an Integrated Development Environment (IDE) for building the applications and components that the .NET framework executes. I refer to them collectively as ".NET".

Visual Studio .NET 2005 (.NET Framework version 2.0) is the third release of Microsoft's latest generation development and run-time environment. Because Microsoft is involved, and in some cases a leader in so many standards bodies, .NET leverages W3C standards. In addition to this, Microsoft publishes its own "standards" such as OLEDB,ADO.NET and others. Because of their size and the sheer size of their developer base, these vendor-driven standards often become more firmly entrenched and achieve wider acceptance than those from standards bodies such as W3C, OASIS and ECMA.There are benefits to being the market leader!

Why not tap into \$7 billion of annual R&D by leveraging a technology that is rapidly being adopted? This information is quoted by Forrester Research in response to a question asking, "Which platform will be used for the majority of your development work in 2004?" Forrester's response: "Four years ago. there was a big question as to whether Microsoft could get [current and new] customers onboard with [the .NET Framework]. That question has been answered: Microsoft has successfully done both." -Randy Heffner, Forrester Research, May 2004. Survey results were 44% J2EE and 56% Microsoft .NET usage.

.NET is really good for building rich GUI, n-tier and Web-based systems. It is also good for developing mobile applications. MultiValue systems traditionally have very little support for doing these things and what functionality exists simply can't be compared with the richness and completeness of what .NET offers.

Main Features of the .NET Framework

■ Common Language Runtime (CLR) There are over 20 programming languages that are supported by the .NET framework, including the ones supplied by Microsoft. The most commonly known ones are C++, C#, VB.NET and J#. The important fact about the CLR is that it allows programs from one language to call methods and even inherit functionality from classes written in another language. This can be done without either class needing to have any special "knowledge" of the other programming language.

The reason this is important is that it means that regardless what language you write a component in, if it is written in a language that uses the CLR, any other programmer, regardless of language, can reuse this component in the future. This also decreases your dependence on a specific programming language, which increases your human resources options.

The CLR is able to do what it does in part because it enforces a few things. In particular data types need to be strongly enforced. The next few topics look in depth at aspects that strongly relate to what the CLR needs to enforce.

Common Type System

In order to allow different programming languages to interoperate, they need to share a common set of data types. Microsoft provides a rich and extensible set of data types. Any type that you extend with your own type can be used by any other programming language that uses the *Continues on page 32*

CLR, but they must all be based on the common types of the Common Type System. As a result of this, the CLR enforces strong typing.

Strong Typing

Visual Basic 6.0 and earlier had a data type called the variant, which was very similar to the MultiValue data type (everything is a string). It would automatically try to convert to the right data type for whatever operation you were doing and could always be referenced as a string. .NET no longer supports this data type.

Strong typing allows .NET to validate that a program is not using a data type in a way that is unsafe, further ensuring security and safety of your code. This is especially important when downloading components over the Internet.

Microsoft Intermediate Language (MSIL)

One of the huge benefits of .NET is that programs are not compiled into machine code, but into an intermediate language called Microsoft Intermediate Language (MSIL).

MSIL is compiled by a Just-in-Time (JIT) compiler (same as Java code) on the system where it is being executed. These JIT compilers have proven to be able to generate code that is as fast, and sometimes faster than precompiled code, as they can actually compile using instructions native to the processors on the machine. They can even optimize for multiple processors.

The really big benefit to you is that the MSIL can be moved to a Windows 32-bit or 64-bit Intel or AMD processor, or can be moved to an ARM processor on an Pocket PC or other mobile device, and the local JIT compiler will figure out the right machine code. This gives you a degree of portability for your application that you could only dream of before, while still giving you some of the best machine optimization (best performance) that you could expect!

Managed Code

For a Windows developer, this is a huge gain as I will discuss below, but first I want to explain why, as a MultiValue developer this should be no big deal to you. You see, you've always worked with managed code.

The word "Managed" in the term really refers to how memory is dealt with. In a MultiValue BASIC program, if you attempt to reference a static array with a subscript that is out of range, you get a "SUBSCRIPT OUT OF RANGE" error, either at compilation time, or at run-time. It is literally impossible to reference the next variable in memory inadvertently because you put the wrong number in the subscript. There is no need (and no way) to "free up" memory for a variable. If you return from the subroutine that declared it (by simply using it), the mem-

ory would be freed up when the system next needed it (garbage collected). All you worried about was putting the right thing into your variable and getting it out. You never worried about allocating or freeing memory, or accessing something you shouldn't.

In traditional Windows programming, this was not necessarily the case. VB programmers are used to having this level of protection, but C++ programmers were not.

Managed Code Is More Secure

CERT bulletins regularly contain a list of exploits that are making the rounds. Windows has its fair share of them, but there is a lot of trouble on other platforms, as well. It is safe to say that nearly all exploits happen in unmanaged code.

Managed Code eliminates whole categories of security exploits. This is one of the reasons for the widespread adoption of Java, which also uses managed code.

For Instance: Buffer Overruns

The exploits which are both the most common and most serious are generally buffer overruns. Without getting into too much detail, a buffer overrun occurs when a program uses a pointer to write to data, and increments or decrements that pointer beyond the boundaries of the variable whose address they are using.

Hackers take advantage of this scenario, resulting in some of the worst exploits.

Regardless whether this happens accidentally or intentionally, it's a bad thing.

■ Managed Code Is Less Prone to Bugs Memory problems related to allocating, freeing and incorrectly referencing memory account for both the majority and most intractable bugs that developers have to deal with. In fact, the exploit listed above could actually be the result of a bug, and not an intentional exploit. I remember a beta ver-

Norton Utilities saved the day for me, but I still lost a lot of time fixing the problem. Something somewhere in the system caused a buffer overrun bug, or referenced invalid memory.

Managed code makes it impossible to do this.

Unmanaged Code

It is possible to create a project using Visual Studio .NET and write unmanaged code or code that is marked "unsafe." There may be situations where you want to use existing logic that counted on use of pointers or call legacy functions that use pointers. Unfortunately, if you use this feature, you can still create code that has buffer overruns and other

memory problems. However:

• You can only do this in some languages (VB.NET does not allow this)

• You have to explicitly choose to do this

• In most languages that allow this, you have to mark the block of code where you are doing this, and,

• The metadata for the assembly notes this fact

• This may be a compliance issue for some IT environments

The last point allows you to enforce policies, so that an assembly (.NET Framework code) that you download over the Internet can be prevented from running unless it contains only "safe" or "managed" code.

Class Libraries

In most interaction with the Windows operating system and peripherals, the .NET framework provides a rich and usually extensible set of libraries which can be used to access system resources and perform other common tasks.

The benefit here is that regardless what your programming language is, you will be using the same libraries. This means that any programmer who becomes familiar with the .NET class libraries will be able to understand what your programs are doing when they interface with these libraries. The benefit to you is that you can call on a large pool of experienced, trained developers for doing this work.

COM Interoperability

.NET makes it easy for you to access legacy COM components. This means if you have existing COM components that you have written or licensed from third parties, you can use them. Keep in mind that these will NOT be written in managed code, so some of the benefits of .NET may be lost by going this route. On the other hand, there are many mature, well tested, reliable COM components available on the market, so having access to these is a true benefit.

Platform Invoke (P/Invoke)

.NET also makes it easy for you to call native Win32 or third party C++ functions. Again, doing this may lose you some of the benefits of managed code and the CLR, but if you have some reliable, mission-critical native code that you need to leverage, .NET makes it easy for you to do this.

ADO.NET

With almost every version of Visual Studio, Microsoft has enhanced the data access strategy. You can always continue to use the old strategy if you really want to, and the newer one is always better than its predecessor.

The current version is ADO.NET 2.0.

ADO.NET is not strictly speaking a library. It is an architecture. Microsoft provides libraries, functions and components that providers and consumers are expected to use or leverage, and a recommended approach to doing various tasks.

About five years ago, at a Microsoft Tech-Ed conference, the IT department head for a large multinational soft-drink company (who will remain unnamed) made the comment, "I don't care if it's a good standard, but if I'm using middleware I won't start until I have a standard!" This is a wise approach, in my opinion. If you are writing in a .NET environment, and you need to access data, your preferred approach should be to use an ADO.NET provider, and preferably one that follows the standard.

In particular, you should look for a provider that:

- Uses 100% safe, managed code for all run-time activities.
- Does not require a proprietary binding layer. If a provider implements their ADO.NET inter faces correctly you won't need anything proprietary — it should just bind. Most providers for MultiValue systems advertise binding objects.
- Supports the ability to "fill" a DataSet from an Adapter object.
- Allows you to create strongly typed datasets. This is a very powerful feature of ADO.NET. Unfortunately, we don't have the space to delve into this at this time.
- Allows you to use the ADO.NET libraries in the way that a .NET programmer would expect.
- Allows you to deal with data inconsistencies in a flexible way.
- Full support for multivalues and subvalues.
- A track record of protecting your investment in their products when new technologies are delivered.





Is Your Data Security Adequate?

Business is Data. Data is Business. As an IT manager or consultant, we know this, but I'm still running into clients that are just now coming to this realization. It usually comes from the following statement: "I can't run my business without my computer."

Now to be honest, this statement usually leads to a disaster recovery plan of some kind, but then they start thinking about other things, and up comes the security question. Most of the time they start thinking about hi-tech security measures like biometrics and other crazy and expensive options. What they don't always realize is that little things can be done without spending a lot of money.

All MultiValue DBMSes provide tools to protect your data, but they aren't being used, or applied to their full advantage. Even if you currently have security measures in place, you'll find a large security problem centered around your users. The user is the weakest part of a security system. Why use security? Most people would say: "To keep unauthorized personnel from accessing or altering information." Yet historically, day-to-day users cause the most common security breach: theft.

The day-to-day users have easy access to your information and will know its value. The users generally have little or no restrictions on what can and cannot be accessed. Users have been known to sell company customer lists and payables and receivables files. How protected are your valuable files?

While data alteration is a security risk, the more common threat is data theft. Most businesses are alert to data alterations and catch it before it causes too many problems. Whereas data theft has

long-term effects that are rarely noticed, if at all, and many times impossible to repair. What would your competition do with your customer lists or accounting information?

Most software packages have basic security features built-in to keep information from being altered, but much of the software you find on MultiValue systems is custom.

Many custom programs overlook, or bypass, existing security measures with the assumption it has already been dealt with.

If your current software does not have security options, then look at the features that are built into the operating system itself. Most MultiValue operating systems, if not all, have common security features such as passwords, file access and update codes, SYS levels, as well as debugger and TCL restrictions.

Passwords are the most commonly used security features in any system. They keep unauthorized personnel out of your data and restrict what information the average user has access to. Yet, passwords can become the weakest part of your security.

your valuable files? The National Computer Security Association (NCSA) determined that in the last five years the following areas have had a dramatic increase in theft:

- Client or customer information 81%
- Trade secrets (i.e.: pricing formulas, manufacturing technologies) - 77.6%
- New product plans 76.7%
- Product descriptions 75.7%
- Pricing data 71.8%

How much of this information is readily accessible to your users? Most of this information is required to operate the day-to-day business. Does your existing security extend beyond the regular logon checks? Users often create this weakness in security without knowing. To avoid this, users should be required to change their password often. Users should avoid easy to remember passwords like names, birthdays, phone numbers, addresses, and so on. They should also avoid using the same passwords repeatedly.

Writing down passwords is another common practice to be avoided. Users often write down passwords on post-it notes or desk calendars so they don't have to remember them. There is nothing like a written down password to cause security problems.

Another feature that can be found in MultiValue operating systems is access and update locks. These locks allow you to create security that the users can do nothing about. Access and update locks are applied to specific files and keep people from accessing and/or changing the information. Using access and update locks do require a little planning to set up, but once in place, they can rarely be changed by anyone other than the creator of the security system.

Other security features that can be found on most MultiValue DBMSes are SYS0, SYS1, SYS2, and sometimes SYS3. These restrictions are placed on whole accounts and restrict the use of specific TCL commands.

All these security features help keep unauthorized people from accessing or altering information, but what about protection against users who do have access? This kind of protection is more statistical analysis than hard protection like passwords.

By keeping audit trails on access and changes to key information, you can define patterns, or the lack of, in data access. Audit trails allow managers to deal with system abuse as well as watch for data theft. One place that audit trails should be closely watched is system access. When are your users accessing the system? How often do they access the system after hours or on their days off?

Another place an audit trail can be placed is on customer inquiry screens

or inventory inquiry screens. How often does this employee access customer information? How long do they spend in the information? Are they accessing unrelated customer accounts one right after the other? I think you get the idea.

Another feature to keep in mind is limiting the kinds of data that is allowed to be printed. By limiting access to the kinds of data that can be printed, you will limit, if not plug, a hole that is often overlooked. Take a look in your accounting department. Do you see any accounts payable or receivable reports lying in the open? How about in the trash?

Since we are still far from a paperless workplace, printed information is found all over the office. Walk through your office. Count how many reports, screen dumps, or other printed material the users have on their desks or in the trash. You'll likely find some type of printout on everyone's desk. More than likely half of what you find will be key information, such as pricing or customer lists.

Every MultiValue operating system has security features built-in. The question is, are you using them? Security should never be limited to features that only keep unauthorized people from accessing or altering data. The most common theft of data will come from the people who already have access to it.

Remember, the weakest part of any security is its users. <u>is</u>

There are perhaps two other extremely important items to consider when thinking about speed: knowledge and patience. By knowing the system you are working on, the types of reports the users ask for, changes likely due to market fluctuations and so on, you can anticipate some of the bottlenecks that may occur. By knowing as much as you can about your development environment, you can probably use existing system functions, rather than reinventing them yourself, poorly. Patience will aid you when the users complain about speed, or when management complains about how long changes take to implement. By observing and examining the issues brought to you, and thinking before jumping into the code to make many small patches, you may be able to make one centralized fix or routine that will give performance gains for years to come.

And finally, we all benefit from newer, faster systems. A rising tide lifts all ships, as the saying goes, so make sure you're in port. OpenInsight systems can run extremely well, and these tips are some of the reasons why you should continue to use it, or start to use it. I'm looking forward to your call. is



flow into the hypercube in near real time without putting operational transaction response time at risk. In OLAP tools other than MITS Discover, any update requires exporting the batches of transactions out of the MultiValue environment into a proprietary OLAP tool or staging area, adding complexity to the solution and limiting operational integration with the OLAP tool. MITS Discover runs within the MultiValue environment which greatly reduces the complexity of using this solution.

Using Hypercubes for OLAP Storage and Navigation

The standard approach for analytical reporting is the OLAP hypercube. Hypercubes arrange aggregate transaction totals along dimensions like customer, product, and date. We can obtain the transaction totals for any combination of dimension values by directly reading data from the hypercube instead of scanning all the source data. The great strength of the hypercube is that the number of underlying source transactions does not affect query speed. The hypercube also facilitates slicing and dicing - swift navigation from summary totals to finer-grained subtotals.

Examples of this technique: slicing subtotals for last month's most profitable sales rep to discover their product line mix and how it differs from under-performers, or discovering how community policing efforts have reduced property crime by area to evaluate program effectiveness.

The advantages to using an analytical reporting tool over writing BASIC programs for management reporting are similar to the advantages report generators have over the command line. Certainly, knowledge of the application and reporting environment is required, but we view these through the lens of a BI tool, not directly using BASIC programming and manual file access, which dramatically reduces the effort and complexity of the solution. We manage and schedule extraction and loading of transactional data automatically. The biggest benefit is the intuitive interaction of the GUI OLAP clients available for analytical reporting tools with their ease of export to spreadsheets.

Summary

This progression from manual approach through application development to managed third-party solution is similar for both operational reporting and analytical reporting. It may benefit your organization to move toward the managed

end of the spectrum with its increased productivity and capability. There are several MultiValue reporting solutions available. 
Rather than choosing their columns, selecting the appropriate records, and then waiting for the report, MITS Report users have the data immediately at hand, and are able to add and remove columns and filters at interactive speeds, seeing the actual data as they go. An added benefit is that the snapshot of data remains static while the MITS Report user is refining the report. With traditional report generators, each modification of a report requires another trip back to the source data, potentially changing the totals each time. With the MITS Report extraction technology, we only access the MultiValue system to refresh the report data as appropriate for the underlying business process, not for every report request. This way we protect the host system — and reduce the number of MultiValue licenses consumed.

We adapted the flexibility of the MITS Discover security model and custom menus to MITS Report. The row and column level security not only keeps information compartmentalized, it allows us to create one master report for use by many different individuals who then see only the data for their department and authority level. This security model also allows us to mix global and user-specific menus seamlessly.
